II. ORDER PROCEDURE

The contract shall be awarded under the tender procedure (The principle of competitiveness)

III. III SUBJECT OF THE ORDER AND ITS DESCRIPTION

Consulting services in the field of internationalization of business activities of the contracting entity as well as training services in the field of internationalization of business activities of the contracting entity for the contracting entity are the subject of the order within the following scope:

1. Consulting services in the field of internationalization of business activities of the contracting entity

- Consulting services concerning internationalization of business activities of the contracting entity on the prospective markets included in the Cosmetic Industry Promotion Program (strategy of entering into one of the largest target markets - CHINA) in order to introduce the product covered by the project (the product line based on the natural collagen).

The scope of the services covers the development of a business model to enter the Chinese market, including such elements like:

- Long-term strategy of entering the Chinese market,
- Schedule for implementation of the business model,
- Export risk management strategy,
- The concept of effective tools and methods of marketing and promotion.
- The executor shall provide the contracting entity with the documentation of the results of the consultancy work carried out (on the form received from the contracting entity) in its full scope as specified in the description of the order subject,
- The services shall be provided from 12.05.2017 to 28.05.2017. The documentation
 of the results shall be transferred to the contracting entity during the training referred
 to below.

2. Training services in the field of internationalization of business activities of the contracting entity

- Training services concerning internationalization of business activities of the contracting entity on the prospective markets included in the Cosmetic Industry Promotion Program (services concerning expansion in one of the largest target markets - CHINA) in order to introduce the product covered by the project (the product line based on the natural collagen).

The scope of the training shall cover the following issues (concerning the entry into the new market - CHINA):

- Methods of the effective search for suppliers/customers,
- Effective negotiations,

- The most common mistakes made in dealing with Chinese partners,
- Avoiding mistakes in negotiations with Chinese customers,
- Tightening trade ties,
- Legal regulations in trade.
- the services shall be provided in Shanghai at the place and time indicated by the Ordering Party from 12.05.2017 to 28.05.2017.

IV. EXECUTOR OF THE ORDER SUBJECT

The request for proposal is addressed to entities actively engaged in business activities i.e. individuals, organizational units having legal capacity or legal persons conducting economic activity (verified by an entry in the register of companies). We invite only those who have the potential to provide the services mentioned above (in the form of a branch of a company, its subsidiaries or associates in the market - the CHINESE market) and the entities being active in this market to participate in the tender procedure.

The contracting entity reserves the right to inspect tenderers' documents showing the fulfillment of the requirements mentioned above on the closing date for submission of tenders and on the next day.

V CONDITIONS FOR THE PARTICIPATION IN THE PROCEEDING

The entities associated with the contracting party personally or capitally are excluded from the proceedings. The contracting entity requires submission of a statement being the Annex No. 2 to the request for proposal in order to confirm fulfillment of the requirement mentioned above.

VI. PROCEDURE FOR THE OFFER SUBMISSION:

- 1. The offer shall be drawn up on the attached form "OFFER FORM" (Annex No. 1 to the request for proposal) in Polish or English.
- 2. The offer should include, in particular:
 - The total net price and detailed prices. In the case of any amounts in foreign currencies, the ordering party will convert these amounts to PLN according to the average exchange rate of the National Bank of Poland in force at the date of issue of the request for proposal.
 - The due date of the accounting document.
 - Information on the experience that is part of the evaluation criterion.
 - The date of preparation and the expiry date of the offer.
 - The tenderer's declaration on the lack of connections with the ordering party (Annex No. 2 to the request for proposal).
 - The tenderer's declaration on the ability to complete the order and the experience in providing similar services (Attachment 3 to the request for proposal). The relevant services are the analogous services for the Chinese market.
- 3. The ordering party reserves the right to reject an offer, which is not consistent with the expected the content and form layout.
- 4. The information contained in this request for a proposal may be used by tenderers only in accordance with its intended purpose, i.e. in order to prepare an offer.
- 5. The selected tenderer will be notified individually in the case of its qualification for further proceedings.



- 6. The validity of the offer not less than 2 months.
- 7. In the event of exceptional circumstances which could not be foreseen at the time of preparation of this request for proposals, the ordering party reserves the right to withdraw from the services covered by this request for proposals, which does not constitute grounds for any claims by the tenderer.
- 8. The ordering party does not allow partial or variant offers to be submitted.
- 9. The contracting entity reserves the right to withdraw from the ongoing contract, if the contracting entity is not able to fulfill the contract. In such a case, the executor shall not be entitled to any financial claims against the contracting entity.
- 10. The ordering party reserves the right to make changes in the conditions of the request for proposal in justified cases as well as to cancel or terminate the proceeding without a selection of an offer, in particular if the value of offers exceeds the amount of funds intended by the ordering party to finance the contract.

VII. CRITERIA FOR OFFER EVALUATION

The executor will be selected based on the criteria.

The points will be calculated using the following formulas:

The score for the price will be calculated based on the formula:

Verification of the offered price:

On the basis of the data from the Annex No. 1 to the request for proposal, i.e. the Tender Form.

The score for tenderer's experience will be calculated based on the following grading scale:

- lack of experience 0 pts.
- Experience: minimum two years 10 pts
- Experience: minimum three years 20 pts
- Experience: minimum 5 years: 35 pts

Verification of the declared experience:

On the basis of the data from the Annex No. 1 to the request for proposal, i.e. the Tender Form as well as of the declaration from the Annex no. 3 to the request for proposal.

The contracting entity reserves the right to inspect the tenderer's documents certifying the relevant experience.

The ordering party shall evaluate offers on the basis of the number of points calculated using the criteria mentioned above and the achieved scores to 100 points (100%=100 point). The amount of points for each criterion will be summed and will constitute the final assessment of the offer.

VIII. THE WAY OF OFFER EVALUATION

- 1. Verifying if the offer meets the requirements (including formal criteria) set out in the request for proposal. The offers meeting the requirements will be further evaluated. The offers not meeting any of the requirements (or formal criteria) will be rejected.
- 2. The ordering party shall consider the most advantageous offer, the offer which obtains the largest number of points for the criteria accepted for this proceeding. In the case of the same number of points, the lowest price is decisive.

IX. GENERAL PROVISIONS

- 1. The ordering party reserves the right to change the content of the request for proposal. If the changes may influence the content of the submitted offers, the ordering party shall extend the deadline for submission of offers. All tenderers, which received the request for proposal and for which it is binding, shall be notified immediately about changes.
- 2. The selection of a tenderer is not tantamount to incurring an obligation in the meaning of civil law.
- 3. The request for proposal and all three annexes to the request for proposal form an integral whole.
- 4. The contractual penalty for improper execution of the order subject by the executer is the lack of payment and 25% of the total price of the entire order.
